Rich Hahn, is currently an I.P. Compliance Legal Coordinator 3 (Paralegal) with Yahoo! Inc., in Sunnyvale, where he specializes in processing notices of copyright infringement submitted under the Digital Millennium Copyright Act (17 USC §512). Mr. Hahn developed his interest in copyright law when reentering the Paralegal field and taking and Intellectual Property class at West Valley College.

The Internet is ever changing and the lines between what materials posted online are protected or not protected by copyright are becoming increasingly blurred. In other words the Online world has become a "Digital West" between those seeking to protect their Intellectual Property and those who believe they can "fairly use" an item that is posted online. The presentation will focus on the basics of copyright, how Online Service Providers can protect themselves from liability for copyright infringement for material posted by third parties on their site, and the process rights holders must follow to have their copyrighted material removed the sites of Online Service Providers.
